Limited Warranty On reliabilt[®] Remanufactured Service Replacement Parts

Terms of Coverage:

Uses

This warranty applies to the first retail purchaser and subsequent owners during the WARRANTY PERIOD of reliabilt[®] remanufactured service replacement Parts (referred to as Part) manufactured and supplied by MTU Detroit Diesel, Inc. (MTU DD).

Defects

This warranty covers Part REPAIRS to correct any malfunction occurring during the WARRANTY PERIOD resulting from defects in material or workmanship.

Repairs

To obtain warranty repairs, defective or malfunctioning Parts must be delivered to an authorized MTU DD service outlet and the outlet furnished with the purchaser's copy of the original sales slip on "over the counter" sales or the repair order on service installations, to validate date of purchase. MTU DD may at its discretion, replace rather than repair the Part. A reasonable time must be allowed to perform the warranty repair after taking the Part to the authorized service outlet. Repairs will be performed during normal business hours.

Warranty Period

The WARRANTY PERIOD begins on the date the reliabilt[®] Part(s) is installed on a MTU DD engine by an authorized MTU DD service outlet or the date of sale on "over the counter" purchases.

Like Replacement Parts

Part(s) used to replace Parts under warranty will assume the identity of Parts replaced and be entitled to the remaining warranty coverage.

Parts Removal and Reinstallation

Reasonable labor costs for Part removal and reinstallation are covered by this warranty only if the reliabilt[®] Part(s) was originally sold and installed by an authorized MTU DD service outlet.

This Warranty Does Not Cover:

Repairs Due To Accidents, Misuse, Alteration, Storage Damage, Negligence or Certain Modifications

Repairs due to an accident, misuse, alteration, misapplication, storage damage, negligence or modification exceeding MTU DD specifications, are not covered by this warranty.

Labor Charges on "Over-The-Counter" Sales

Labor costs for Part removal, repair and reinstallation are not covered by this warranty when the Part was purchased "over-the-counter".

MTU-DD No-Charge Parts

This warranty does not apply to Parts provided by MTU DD at no-charge.

Incidental or Consequential Damages

MTU DD is not responsible for incidental or consequential costs or expenses which the owner may incur as a result of a malfunction or failure covered by this warranty, such as communications expenses, meals, lodging, overtime, towing, loss of use of the Part or equipment, loss of time, inconvenience, cargo loss or damage, and other similar costs and expenses.

Owner Responsibilities

Owner is responsible for non-Part repairs, cargo damage, all applicable taxes, all business costs and other loss resulting from a Warrantable Failure.

Other Limitations

The performance of REPAIRS is the exclusive Owner's remedy under this warranty. MTU DD does not authorize any person to assume or create for it any other obligation or liability in connection with the Parts.

THIS LIMITED WARRANTY IS THE ONLY WARRANTY APPLICABLE TO reliabilt[®] REMANUFACTURED REPLACEMENT PARTS. MTU DD MAKES NO OTHER WARRANTIES EXPRESS OR IMPLIED, INCLUDING ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. MTU DD SHALL NOT BE LIABLE FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES AS DESCRIBED ABOVE.

Some states do not allow the limitation of how long this warranty may last or the limitation or exclusion of incidental or consequential damages, so the above may not apply to you. This warranty gives you specific legal rights, and you may also have other rights which may vary from state to state.
